## HIGHLIGHTS FROM THIS YEAR'S WORK AROUND THE WORLD

# MISSION TRIPS 2015

### MACAU

Dr. Ligaya Acosta travelled to Macau in February.

**FEB** Joining her were HLI President Fr. Shenan J. Boquet and HLI Director for Research and Education Dr. Brian Clowes. Dr. Acosta gave pro-life training to the Macau youth, speaking on the topic, “Pre-Marital Sex, Contraception, Abortion: Why Not?” and focusing on all the pressing issues affecting the youth in Macau. Afterwards, Dr. Clowes and Fr. Boquet expanded on these pressing issues with their presentations. Training sessions were later given at St. Augustine Church for around 1,500 people; and a third training session was given at the Pro-Life Symposium for around 350. Top officials of the Philippine Consulate in Macau attended, including Consul General Lilibeth Diapera.

### NEW ZEALAND

Raymond de Souza traveled to New Zealand in February.

**FEB** The purpose of this mission trip was the 20<sup>th</sup> Wellington Eucharistic Convention, which included about 450 attendees. Among his talks, Raymond spoke on “The De-Christianization of Western Culture and the Gospel of Life,” analyzing the

elements of death in contemporary culture—namely, contraception, abortion, euthanasia and same-sex “marriage”— according to St. John Paul II’s encyclical *Evangelium vitae*, encouraging attendees in a three-fold response to the Culture of Death: prayer, study, and action.

### DOMINICAN REPUBLIC

Mario Rojas visited the Dominican Republic in March.

**MAR** There, he presented the educational video “Population Control” from the HLI video series “HLI Lifelines.” He expounded on the myth of population control and gender ideology. With Mario was Raymond de Souza, who

spoke on the harmful effects of contraception around the world. While there, they also conducted a live radio interview on Radio Juventus Don Bosco and a TV interview on *TeleVida*. They spoke at length about the work of HLI and the necessity of teaching people to defend Life, Faith, and Family, especially the young.

Mario Rojas joined Human Life International in 2009, and directs HLI's affiliates in Latin America. He resides in Bolivia.

## PANAMA

In April, Mario Rojas and Marlene Gillette-Ibern travelled to Panama for the Seventh Summit of the Americas.

**MAR** This event is held every three years with the leaders of the 35 member states of the Organization of American States (OAS). HLI representatives attend this events in order to work with

other pro-life, pro-family groups to fight for language protecting the life and dignity of the most vulnerable in OAS declarations.

In one session, Mario Rojas obtained inclusion of language protecting parents in the education and formation of their children. At another session, Ana-Melissa Español (a member of HLI Panama Foundation for Life and Family) assisted in having the principle of re-

spect for the health of the human person recognized as an inalienable human right. Marlene Gillette-Ibern was able to prevent incorporation of “respect for Mother Earth” and obtain incorporation of language in favor of human rights in the recommendations during another session. All representatives for HLI worked very hard during the other sessions, and had similar success in changing OAS resolution language.

## NAMIBIA

In May, Emil Hagamu traveled to Namibia.

**MAY** There, he helped organize a three-day pro-life training conference for clergy, religious, and lay leaders in the country. In many cases, even consecrated religious had to be reminded about Catholic Church teaching on homosexuality. Many members of our faith do not see the intrinsic evil of homosexual actions, using such arguments as “Are they not human beings created in the image of God?” to justify toleration.

During the conference, Emil discussed God’s divine plan for human

procreation and man’s obligation to be fruitful and multiply to fill the earth. He also spoke about the spiritual and physical threats to the culture, and how to strengthen the sacred institution of marriage in society.

## SOUTH AFRICA

In May, HLI President Fr. Shenan J. Boquet and HLI Director of Research and Education Dr. Brian Clowes traveled to Cape Town, South Africa.

**MAY** They joined Emil Hagamu to help organize and define the mission and goals for pro-lifers in this region and to pro-

vide them with materials to fight the battle. During their stay, they participated in a wide range of activities, from picketing a Marie Stopes International abortion center to doing interviews for (EWTN).

## TURKEY

In May and June, Dr. Ligaya Acosta made her first mission trip to Turkey.

**June** There, she met with His Excellency Bishop Louis Pelâtre, A.A., the Vicar Apostolic of Istanbul, Turkey to discuss pro-life training conferences in Turkey for clergy, religious, and lay leaders. She was also able to conduct a pro-life training session to 70 people on the Church teaching on contraception, abortion, and natural family planning, which lasted nearly three hours. One resolution from this trip is the plan for Dr. Acosta to return after Easter 2016 with a pro-life training mission that will hopefully include many bishops.

## MALAYSIA

In September, Dr. Acosta made a trip to Malaysia.

**Sept** The primary purpose of this trip was to attend a Pro-Life Congress organized by HLI

affiliate Human Life Service (HLS) that was held in Miri. To maximize the trip, Dr. Acosta also flew to Kuching for two similar congresses – one with church leaders of the Diocese of Kuching and another one exclusively for seminarians and priests of St. Peter's College Major Seminary, also in Kuching.

## IRELAND

Fr. Shenan J. Boquet and Dr. Brian Clowes flew to Ireland to meet Patrick McCrystal, Director of HLI Ireland, in September.

**Sept** The mission was to inform, encourage, and activate pro-lifers to stand up and resist the tide of death, which threatens to engulf their nation. They began the trip with a four-day Catholic Pro-Life Activist's Training Course at the Legionaries of Christ Center in Leopardstown, Dublin. They covered an immense amount of mate-

rial, from organizing to history, and talked about specific issues from abortion to in-vitro fertilization to homosexuality.

## VIETNAM

In October, Dr. Ligaya Acosta and Dr. Brian Clowes traveled to Vietnam.

**Oct** They conducted a three-day training program on "Building a Culture of Life and Love." Dr. Clowes spoke on the anti-life agenda, and Dr. Acosta spoke about the problems of contraception. Throughout the three days of training, there were ample open forums for everyone to ask questions.

# TRAINING Priests & Seminarians

## Zambia

Emil Hagamu traveled to Zambia in October for his third visit to St. Dominic's Major Seminary, where 144 seminarians study systematic and pastoral theology.

On the first day, Emil's presentation focused on the Culture of Life, beginning with the mission of the pro-life movement, a talk on the beginning of human life, fetal development, and the sacredness of human life. Topics on marriage and family were presented on the following day, together with a presentation on the threats to life, marriage, and family: contraception, abortion, euthanasia and reproductive technologies. On the third day, he gave presentations on abortion, contraception, and reproductive technologies, ending his talks on the subject of Billings Ovulation Method for Natural Family Planning.

As Emil completed the training sessions, some seminarians resolved to start a pro-life club at the seminary. About 36 seminarians formed the first Pro-Life Club, devoting themselves to the pro-life movement in a special way in order to promote pro-life activism and become proactive in matters of Life, Faith, and Family.

## Benin

In June and July of this year, HLI organized our first Francophone Africa Priest Institute in Benin, Africa.

HLI has had a fantastic response to our Seminarians for Life International program in Benin. Our program grew in tandem as the Church in Benin added two new major seminaries to the original St. Gall Seminary in Ouidah because of the growing number of vocations. Our pro-life seminarian program is active in all of Benin's seminaries.

This is largely a tribute to George Wirnkar's work over many years.

We decided that Benin was the best place to encourage our "graduates" from the HLI seminarian pro-life program and start groups of pro-life priests in their respective countries. These young priests are carrying out their apostolates in a wide variety of settings, from parishes to chaplaincies and other ministries. We gathered 88 priests, 10 sisters, 18 seminarians and 8 lay people from Burkina Faso, Mali, Benin, Cote d'Ivoire, Cameroon, the Democratic Republic of the Congo, Chad, Togo, Nigeria and Cameroon. We brought the priests in from these different countries and gave presentations and HLI pro-life materials to take back with them, including pro-life films, books, and HLI's St. Michael prayer cards for the conversion of abortionists.



## Training Priests and Seminarians

Our theme this year was “Consecrated Persons: Contemporary Challenges to the Christian Family.” It was wonderful to hear the testimonies of these fervent young priests. Fr. Benoit Toum from Cameroon described how he was so enthusiastic to start work in pro-life and pro-family ministry after his contact with HLI that his bishop appointed him to direct the Family Life Office of the diocese when he was still only a transitional deacon! Here is his description of his apostolate: “I visit numerous parishes and write letters inviting couples to recollections, weekends for couples, talks and meetings focused on family life. Every week I host an hour-long program on Radio Maria Cameroon called ‘family crossroads.’ I pay special attention to situations where people are ‘wounded in their affective life.’ I encourage couples to live in an upright way with family and

Christian values. Currently, I am setting up a pro-life program and the teaching of natural methods of birth regulation.” We can look forward to 50+ years of fruitful sowing of the Gospel of Life by Fr. Toum, who was ordained to the priesthood in 2013.

We were very happy to have HLI President Fr. Shenan J. Boquet as the main speaker at this conference. He spoke to encourage these men to continue defending Life and Family as a central aspect of their priestly ministry. Fr. Boquet showed how our educational apostolate, which focuses on Contraception, Abortion, Euthanasia, Reproductive Technologies, and Marriage & Family could really transform parishes and the Church, using the pastoral plan Pope St. John Paul II originated for creating a Culture of Life.

After seeing the enthusiasm with which our pro-life resources were re-

ceived by these pro-life priests, it is clear that we must redouble our efforts to equip them and the young seminarians who are coming forth in ever greater numbers from the world’s “Spiritual Super-Power,” as Pope Benedict XVI called Africa.

# TRAINING PRIESTS & SEMINARIANS IN Latin America

Through HLI's REDESSVIDA program (the Latin American Network of Priests and Seminarians for Life) our national, regional, and international congresses have trained thousands of priests and seminarians across Latin America to defend life from conception until natural death.

The main audiences for these congresses are Catholic priests and seminarians. These men can have a great impact in mobilizing communities against the Culture of Death, but many are lacking formation in Life and Family issues and need HLI's training and resources to effectively change the culture.

## Training Priests & Seminarians in Latin America

In August of this year, Human Life International sponsored our 7th International REDESSVIDA Congress in San Miguel de Tucumán, Argentina to train and equip priests, seminarians, and lay faithful to understand and combat the many threats to the sanctity of life and the family around the world.

While REDESSVIDA congresses have been held in many countries in Latin America, this was the first time HLI's pro-life missionaries were able to organize this comprehensive pro-life training for priests and seminarians in Argentina. And although this was HLI's first major pro-life congress here, HLI has had a presence in Argentina for several years under the leadership of HLI Argentina Director Dr. Oscar Botta.

The congress was split into two parts lasting four days: two days of training priests and seminarians and two days training lay community leaders. The opening ceremonies for the congress were presided over by His Excellency Alfredo Zecca, Archbishop of the Diocese of Tucumán.

HLI Regional Director for Latin America, Mario Rojas, was a main presenter at the congress and made an eloquent speech for the young adults present. Mario also introduced a pre-recorded video message from HLI President, Fr. Shenan Boquet, who was unable to attend, addressing the participants and giving his blessings for the congress.

Fr. Boquet thanked all the participants for recognizing the importance of HLI's REDESSVIDA congress in combating the threats to Life and Family. "No one can be on the sidelines," he said. "We all must be engaged."

"We are seeing societies around the world collapse because they are embracing a secular mentality and are rejecting life, rejecting the family ... it's up to us, it's up to you, to be engaged," he told attendees.

Speaking with Mario, one priest who attended, Fr. Gabriel Barros, IVE, fully embraced Fr. Boquet's message of needing to be engaged to change the culture. Fr. Barros said it was "an obligation [for all priests] to all the souls God has entrusted to us" to receive this pro-life training and work in an active way to defend Life.

When the 7<sup>th</sup> International REDESSVIDA Congress came to an end, Mario presented a token of thanks to Fr. Marcelo Barrionuevo, Vicar of Faith and Culture for the Archdiocese of Tucumán, and the lay pro-life leaders who helped organized the congress. The "Tucumán Proclamation" was read by Fr. Marcelo Barrionuevo at the close of the congress. It highlighted the truth that "Life is a gift from God" and expressed the urgent need for continued pro-life training of seminarians, priests, and laity.

It will require a great effort of prayer, formation, and action to raise new pro-life leaders to guide the faithful towards the final victory. With the financial support and prayers of the HLI Family, our pro-life missionaries will continue the life-saving mission of building a Culture of Life. Please continue to pray for HLI's REDESSVIDA program and for all of our pro-life efforts around the world!

# Conferences

Each year, HLI participates in conferences, where either much larger numbers of people can be reached or where we can collaborate with other organizations. This year, we participated in four major conferences.

## ASPAC Conference: Taiwan

Human Life International has conducted 20 Asia-Pacific Congresses (ASPACs), that have addressed virtually every aspect of the battle between the Culture of Life and the Culture of Death. More than 10,000 people have attended these ASPACs, and we have reams of letters and testimonies attesting to their effectiveness in motivating people to take action.

The goals of the 26 talks given at the 2015 ASPAC were to promote the moral teachings of the Catholic Church, particularly with regards to sexuality; to outline God's wonderful plan for marriage and family; to show the specific threats presented by the Culture of Death in the forms of abortion, population control, homosexuality and the gender ideology; and to present concrete and effective programs designed to defend Faith, Life and Family. Judging by the many comments and questions the speakers fielded, we were successful in accomplishing our goals.



## World Prayer Congress for Life: Fatima, Portugal

In October, 2015, HLI Austria and our US Headquarters teamed up to organize a spectacular and unique pro-life event, part pilgrimage/retreat and part pro-life educational conference and activist training. The seventh World Prayer Congress for Life in Fatima, Portugal, was a return to the site of our first global prayer congress in 2006.

Timed to coincide with the 20th anniversary year of the great pro-life encyclical *Evangelium Vitae* by Pope Saint John Paul II and the opening of the Synod on the Family in Rome, this prayer congress had a full agenda. The overall theme was, "That they might have life" (John 10:10). The first talk was by HLI President Fr. Shenan J. Boquet, entitled, "In hoc signo vinces—The pro-life generation will win." His supernatural perspective left no doubt that unless we are rooted in Christ, we will labor in vain.

Several bishops addressed the prayer congress, most notably His Excellency Juan Antonio Reig Plà of Alcalà de Henares in Spain. He gave a rousing talk on paragraph 92 of *Evangelium Vitae* on the family as the sanctuary of life.

This HLI congress was jam-packed with wonderful teaching and events. The participants were challenged and refreshed by these days of prayer, study, and action.



## World Congress of Families IX: Salt Lake City, Utah. USA

---

For the 3,300 attendees of World Congress of Families IX in Salt Lake City, the late October meeting was a time of rejuvenation and activation. Most were actively involved in the fight for life and family, coming from more than 30 countries and representing several different faiths.

The scholars, political leaders, artists and activists who participated in the Congress all shared the common conviction that the natural family is under attack, and that now is the time to work together with those of different faiths to have as wide of an impact as possible.

Representing Human Life International were Development Specialist Colleen Leahy and Director of Mission Communications Stephen Phelan, who spoke at four different sessions. His talk on “Fatherhood and Social Justice” dealt squarely with the contradiction between the stated intent of those “social justice warriors” who would redefine marriage based on radical sexual ideology, and the overwhelming sociological data that indicate that the more the natural family is abandoned, the more problems with social justice a society is likely to have.

### Symposium on the Family and Marriage: Rome

---

The Kolbe Center for the Study of Creation in collaboration with Human Life International, organized an International Symposium entitled “The Two Shall Become One” in order to shed light on the family and marriage, using the creation of Adam and Eve as the point of departure for the Church’s doctrine on marriage.

Experts in theology, philosophy, and the natural sciences demonstrated how the traditional doctrine of the Church on creation affirms the truths that the Church has always held about the nature of marriage.

## HLI Welcomes New Rome Office Director

FATHER FRANCESCO GIORDANO, a diocesan priest and professor in Rome, Italy, was named the new director of the Rome office of Human Life International on July 14, 2015. He succeeds Monsignor Ignacio Barreiro-Carambula, who represented HLI in Rome for 16 years before moving to HLI's World Headquarters in 2014.

"Father Francesco emerged early as an excellent candidate to continue Monsignor's and HLI's essential work in Rome," said Father Shenan J. Boquet, President of HLI. "A young and faithful priest who has a heart for the defense of life and family and excellent academic credentials, Father Francesco is a welcome addition to the HLI family. And since he came highly recommended from Monsignor Barreiro himself, we are very confident that Father can continue to grow HLI's impact in Rome with Church officials, as well as with priests and seminarians in academia."

While a seminarian, Father Francesco was one of many who made regular use of HLI's bioethics library, where he met Monsignor Barreiro in 2006. He intends to promote this feature of HLI's outreach in Rome: "The idea of the library in the office is key because that way we work directly with lay, religious, and priest students from around the world working on important issues in bioethics."

Fr. Francesco received his BA from Vanderbilt University in Tennessee, an MA from the University of Chicago, and a doctorate in systematic theology from Santa Croce University in Rome.

"The theological and educational background of Fr. Giordano will be very helpful as he assists those who pursue graduate studies in Rome," said Monsignor Barreiro. "One of the main activities of the Rome Office is to work with priests and seminarians, encouraging them to strengthen their formation on life and family issues and to be strong defenders of the constant teachings of the Church on life and family."

"I see myself trying to continue that role as best I can since I myself benefited very much from Monsignor Barreiro's guidance during my licentiate and doctoral studies in Rome. As a professor in different Roman pontifical universities, working with seminarians from around the world, I see that as an added benefit," added Father Giordano.

The oldest of three brothers born in different countries around the world, Father Francesco has had both an international perspective and a great love of the Catholic faith from a young age, which made his decision to become a priest a natural one. He credits a love of the traditional liturgy and the good example of many priests and bishops as being key to his discernment of his own vocation, and friendships developed in America with sparking his interest in the defense of life and family.

HLI's Rome Office is key to HLI's mission to defend life and family from the heart of the Church, employing Catholic social and moral doctrine in addition to scientific and data-based arguments. With this perspective, the HLI Rome Office coordinates with other pro-life and pro-family organizations and networks with curial officials and other partners in Rome.


